'Now,' said the professor as the laughter subsided, 'I want you to recognize that this jar represents your life. Sport Pilot & Private Pilot Ground School

1. Answer C is correct.

49 CFR Part 830.5 states [edited to include only those items most likely to pertain to General/Light Sport aviation – ed.]:

The operator of any civil aircraft, . . . shall immediately, and by the most expeditious means available, notify the nearest National Transportation Safety Board field office when:

An aircraft accident or any of the following listed incidents occur:

Flight control system malfunction or failure;

Inability of any required flight crewmember to perform normal flight duties as a result of injury or illness;

In-flight fire; or

Aircraft collide in flight.

Damage to property, other than the aircraft, estimated to exceed \$25,000 for repair (including materials and labor) or fair market value in the event of total loss, whichever is less.

An aircraft is overdue and is believed to have been involved in an accident.

2. Answer A is correct.

3. Answer B is correct.

A spin may be described as an aggravated stall that results in what is termed "autorotation" wherein the airplane follows a corkscrew path in a downward direction. In order for an aircraft to spin, there must be a stall.

"Partially Stalled" is incorrect because a wing (or a relatively large portion thereof) needs to be totally stalled in order to spin. "Diving spiral" is likewise incorrect because a diving spiral is not a spin, but a different maneuver. In short, you will not get into a spin if you don't get into a stall first!

4. Answer B is correct.

AC 61-23, chapter 1 states:

A stable airplane will tend to return to the original condition of flight if disturbed by a force such as turbulent air. This means that a stable airplane is easy to fly; however, this does not mean that a pilot can depend entirely on stability to return the airplane to the original condition. Even in the most stable airplanes, there are conditions that will require the use of airplane controls to return the airplane to the desired attitude. However, a pilot will find that a well-designed airplane requires less effort to control the airplane because of the inherent stability.

August Board Meeting

We had two much abbreviated meetings this time. The August board meeting was held at **Rick's Metro Embroidery** on August 23rd. We learned of a boat broker who is interested in selling the **22 ft Catalina** stored in **Paul Hershoin's** yard. The boat is listed in **Boat Trader** for \$5500. It has a new 4 hp Yamaha engine.

Young Eagles was the next topic. Rick suggested that flyers and cards be designed. Our next flights will be October 18th.

Paul has informed us that things at our local airports have taken a turn for the worse. The County has hired consultants to advise them on how to make more money from the airports. This means higher fees and less service. In addition they are driving small businesses from the airport with new and stricter minimum standards for insurance.

Parts for the **Bobcat** that was sent to **Boynton Beach Aviation Program** have been located in the hangar, and will be picked up and given to the high school.

September Member Meeting

The September member meeting was held at **Palm Beach Propeller** in **Lantana** on the 11th at 7:30 P.M. We conducted a very brief membership meet. There were two students from **Boynton Beach High School Aviation Program** attending with two of their parents. We also had two guests and a prospective new member.

Topics mentioned were: updates on the boats, airport insurance standards, and importance of contacting our legislators to voice outrage with the way the airports are run (by people with no aviation background and no concern with it except to maximize profit). A plea was made by **Paul Hershoin** and **Bill Perry** to visit the **EAA** web site for information on who to contact, and for samples of letters to write.

A note was made to pilots who want to fly **Young Eagles** on October 18th, and a reminder that we want the signatures of both parents on the permission slips from now on.

We then went on to the tour of the facility. Thirty members and guests were split into three groups. Our hosts were owners **Mike O'Neill** and **Larry Harris**; joining them was employee **Jeff Hebron**. Each led a group. Also


